

INVESTMENT STRATEGY

The Global Value Fund II – Currency Unhedged invests primarily in foreign equity securities that the Adviser believes are undervalued, but also invests on a more limited basis in U.S. equity securities when opportunities appear attractive. Investments by the Fund are focused for the most part in developed markets with some exposure to emerging markets. Unlike the Global Value Fund, the Global Value Fund II – Currency Unhedged does not seek to reduce currency risk by hedging its perceived foreign currency exposure back into the U.S. dollar, and will be exposed to currency fluctuations.

COMMITMENT OF THE ADVISER

As of September 30, 2020, the current Managing Directors and retired principals and their families, as well as employees of Tweedy, Browne, had more than \$1.2 billion in portfolios combined with or similar to client portfolios, including approximately \$5.8 million in the Global Value Fund II. Investment Committee members have spent between 17 to 45 years working at Tweedy, Browne. No principal has ever left the firm except for the reason of retirement.

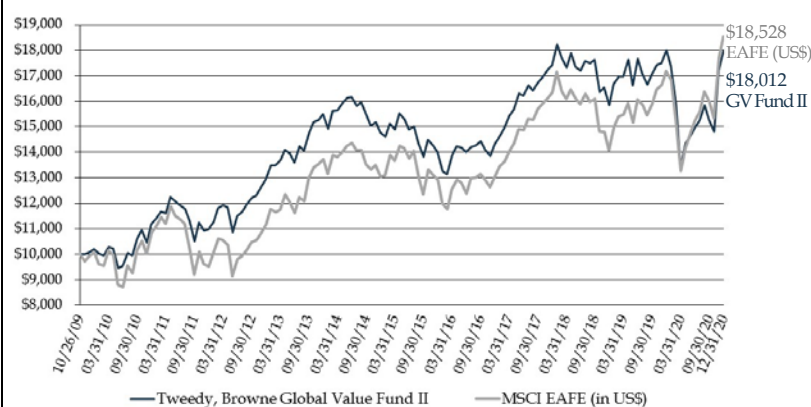

2 Tweedy, Browne has voluntarily agreed, through at least July 31, 2021, to waive a portion of the Fund's investment advisory fees and/or reimburse a portion of the Fund's expenses to the extent necessary to keep the Fund's expense ratio in line with the expense ratio of the Tweedy, Browne Global Value Fund. (For purposes of this calculation, the Fund's acquired fund fees and expenses, brokerage costs, interest, taxes and extraordinary expenses are disregarded, and the Fund's expense ratio is rounded to two decimal points.) The performance data shown above would have been lower had fees and expenses not been waived and/or reimbursed during certain periods.

3 The MSCI EAFE Index is free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed markets, excluding the U.S. and Canada.
