

INVESTMENT STRATEGY

The Global Value Fund II – Currency Unhedged invests primarily in foreign equity securities that the Adviser believes are undervalued, but also invests on a more limited basis in U.S. equity securities when opportunities appear attractive. Investments by the Global Value Fund II are focused for the most part in developed countries with some exposure to emerging markets. Contrary to our other international mutual fund, the Global Value Fund, the Global Value Fund II – Currency Unhedged does not seek to reduce currency risk by hedging its perceived foreign currency exposure back into the U.S. dollar and will be exposed to currency fluctuations.

COMMITMENT OF THE ADVISER

As of June 30, 2019, the current Managing Directors and retired principals and their families, as well as employees of Tweedy, Browne, had more than \$1.2 billion in portfolios combined with or similar to client portfolios, including approximately \$6.8 million in the Global Value Fund II – Currency Unhedged. Our Managing Directors have been with the firm for tenures ranging from 28 to 45 years. No partner in the history of Tweedy, Browne has ever left the firm except for the reason of retirement.

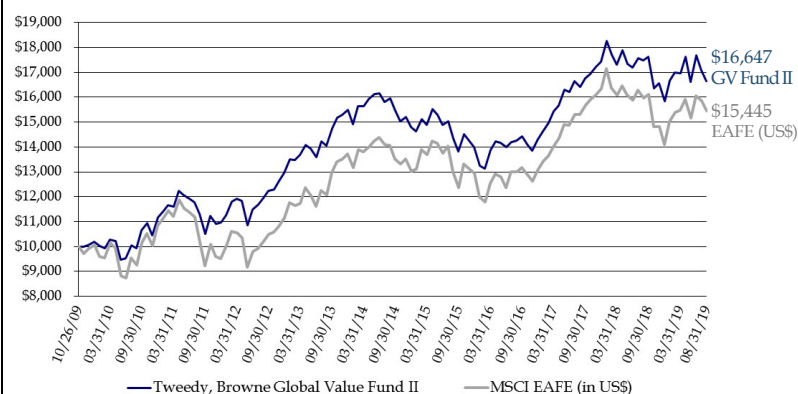

(For purposes of this calculation, each Fund's acquired fund fees and expenses, brokerage costs, interest, taxes and extraordinary expenses are disregarded, and each Fund's expense ratio is rounded to two decimal points.) The performance data shown above would have been lower had fees and expenses not been waived and/or reimbursed during certain periods.

Index Description
